

## VOLUNTARY CEASE AND DESIST ORDER

Respondent, Damion M. Rockwell, D.M.D., who resides at or who operates his/her business at 675 Greenwood Ave, NE., #110, Atlanta, GA 30306, currently does not possess a permit to practice general anesthesia or conscious sedation in the State of Georgia, pursuant to the Official Code of Georgia Annotated (O.C.G.A.) T. 43, Ch. 11, as amended. Potential violations of O.C.G.A. T. 43, Ch. 11 having been called to Respondent's attention, Respondent hereby agrees to voluntarily cease and desist from any practice that would require a permit under O.C.G.A. T. 43, Ch. 11, as amended, until such time as Respondent may become properly permitted by the Georgia State Board of Dentistry ("Board").

Respondent understands that he/she has a right to a hearing in this matter, and hereby freely, knowingly, and voluntarily waives such right. Respondent also understands that should he/she apply for a permit with the Board, the Board shall have access to this Order and to the entire investigative file on this matter.

This Order shall become effective immediately upon acceptance thereof and docketing by the Georgia State Board of Dentistry, and shall remain in effect until such time as the Respondent becomes permitted with the Board, or until further order. Respondent understands that this document will be considered to be a public record entered as the final disposition of any injunction or cease and desist proceedings presently pending or which could be brought against Respondent by the Board, and that this action shall be considered to be and may be recorded as a

final order of the Board. This Order is not intended and shall not be construed as prohibiting the prosecution of Respondent by any other state or federal agency for Respondent's conduct nor shall it be construed as limiting the Board's authority to subsequently impose a fine or conditions upon licensure with the Board.

Any violation of this Order shall subject the Respondent to a fine not to exceed \$500.00 for each transaction constituting a violation thereof, pursuant to O.C.G.A. § 43-1-20.1.
