During the public hearing, anyone may present data, make a statement, comment or offer a viewpoint or argument whether orally or in writing. Lengthy statements or statements of a considerable technical or economic nature, as well as previously recorded messages, must be submitted for the official record. Oral statements should be concise and will be limited to 5 minutes per person. Additional comments should be presented in writing. Written comments are welcome. To ensure their consideration, written comments must be received prior to July 5, 2024. Written comments should be addressed to Executive Director of the Georgia Board of Dentistry at 2 Martin Luther King, Jr. Drive SE, East Tower, 11th Floor, Atlanta, GA 30334. The proposed rule adoptions will be considered by the Georgia Board of Dentistry during its meeting <u>scheduled to begin at 10:00 AM on July 12, 2024</u> at the Department of Community Health at 2 Martin Luther King, Jr. Drive SE, East Tower, 11th Floor, Atlanta, GA 30334. According to the Department of Law, State of Georgia, the Georgia Board of Dentistry has the authority to adopt the proposed rule adoptions pursuant to authority contained in O.C.G.A §§ 43-11-1, 43-11-7, 43-11-9, 43-11-73.1, and 43-11-74.

At its meeting on March 1, 2024, the Board voted that the formulation and adoption of these adoptions do not impose excessive regulatory cost on any licensee and any cost to comply with the proposed adoption cannot be reduced by a less expensive alternative that fully accomplishes the objectives of O.C.G.A §§ 43-11-7 and 43-11-9.

At its meeting on March 1, 2024, the Board also voted that it is not legal or feasible to meet the objectives of O.C.G.A. §§43-11-7 and 43-11-9 to adopt or implement differing actions for businesses as listed at O.C.G.A. § 50-13-4(a)(3)(A), (B), (C) and (D). The formulation and adoption of these adoptions will impact every licensee in the same manner, and each licensee is independently licensed, owned and operated and dominant in the field of dentistry.

### SYNOPSIS OF PROPOSED ADOPTION OF THE GEORGIA BOARD OF DENTISTRY RULE RULE 150-5-.08 USE OF A DENTAL DIODE LASER BY A DENTAL HYGIENIST.

- **Purpose:** To provide for the use of a dental diode laser in the practice of dental hygiene, under direct supervision.
- Main Features: Specify the conditions, and circumstances underwhich a dental hygienist may utilize a dental diode laser in the practice of dental hygiene. Define the prerequisite training and continuing education requirement relative to dental diode laser use by a dental hygienist. Specify the record keeping requirements attendant to the use of a dental diode laser in the practice of dental hygiene.

# Rule 150-5-.08 Use of a Dental Diode Laser by a Dental Hygienist

- A dental hygienist, under the direct supervision of a Georgia licensed dentist may use a dental diode laser limited to the use of bacterial reduction/disinfection of the gingival sulcus at settings that preclude hard and soft tissue removal except for incidental gingival curettage, provided:
  - (a) Prior to utilizing a dental diode laser, the dental hygienist must successfully complete interactive didactic and clinical training which includes laser safety, infection control, patient management and the operation of the specific laser(s) utilized in the dental practice. Training must consist of not less than 8 hours of instruction, and must be obtained through a course provided or recognized by any of the following organizations, a successor organization thereof, or approved by the Board:
    - 1. The Commission on Dental Accreditation of the American Dental Association;
    - 2. The American Dental Association Continuing Education Recognition Program; or
    - 3. The Academy of General Dentistry Program Approval for Continuing Education.
  - (b) <u>A dental hygienist utilizing a dental diode laser shall maintain evidence of required</u> <u>training which shall be prominently displayed at the location where the dental hygienist is</u> <u>authorized to utilize a dental diode laser.</u>
  - (c) <u>A dental hygienist utilizing a dental diode laser shall complete two (2) hours of</u> <u>continuing education every two (2) years in the use of dental diode lasers in the practice</u> <u>of dental hygiene.</u>
  - (d) All lasers shall be used in accordance with accepted safety guidelines.
- (2) When utilizing a dental diode laser pursuant to this Section, a dental hygienist shall document the following information in the patient's record:
  - (a) the type of laser utilized, including the wavelength of the laser;
  - (b) the settings used, such as pulse or continuous wave, and the power setting;
  - (c) local anesthesia used, if any; and
  - (d) the procedure attempted/performed, including details as to whether hard or soft tissue was removed.
