**Open Session**

Dr. Godfrey established that a quorum was present and called the meeting to order at 8:35 a.m.

Dr. Greg Goggans made a motion and Dr. Tom Godfrey seconded and the Committee voted to enter into **Executive Session** for the purpose of receiving legal advice as authorized under O.C.G.A. §§50-14-1(e)(2)(c), 50-14-2(1). Voting in favor of the motion were those present who included Dr. Greg Goggans and Dr. Tom Godfrey.

**Executive Session**

The Committee received legal advice regarding Rule 150-13-.01 Conscious Sedation Permits, Chapter 150-26 Mobile Dentistry, and Rule 150-7-.04 Dental Provisional Licensure by Credentials.

No votes were taken in Executive Session. Dr. Godfrey declared the meeting back in Open Session.

**Open Session**

**Introduction of Visitors**

Dr. Godfrey welcomed the visitors.

**Approval of Minutes**

Dr. Godfrey requested an amendment to the minutes presented. Dr. Goggans made a motion to approve the April 10, 2015 minutes as amended. Dr. Godfrey seconded and the Committee voted unanimously in favor of the motion.

**Discussion Topics**

**Chapter 150-25: Default on Obligations**

Dr. Godfrey called for comments from the Committee and the public regarding the proposed rule chapter. Having received no comments, Dr. Goggans made a motion to present the rule chapter to

the Board for a vote to post notice of intent to adopt. Dr. Godfrey seconded and the Committee voted unanimously in favor of the motion.

Chapter 150-26: Mobile Dentistry; Rule 150-13-.02: Deep Sedation/General Anesthesia Permits; Rule 150-13-.01: Conscious Sedation Permits; Rule 150-7-.04: Dental Provisional Licensure by Credentials

Dr. Godfrey called for comments from the public. Having received no comments, Dr. Goggans made a motion to table these rules for discussion at a future meeting. Dr. Godfrey seconded and the Committee voted unanimously in favor of the motion.

Rule 150-7-.03: Volunteers in Dentistry

Dr. Godfrey called for comments from the public. Ms. McClatchey asked if the continuing education obtained must be from a provider approved by the Board. Dr. Godfrey stated that the continuing education should be from a provider approved by the Board, by reference to the requirements under Rule 150-3-.09. Dr. Goggans made a motion to table the rule so that the proposed amendments could reflect the requirement of approved continuing education. Dr. Godfrey seconded and the Committee voted unanimously in favor of the motion.

Dr. Godfrey asked if there were any other matters to be presented to or discussed by the Committee. There being no further business to come before the Committee, the meeting was adjourned at 9:16 a.m.
