She added that they stopped issuing certificates and now they are asking what they need to do to become board-approved. Dr. Holcomb appointed Dr. Godfrey, Dr. Goggans and Dr. Mayfield to an ad hoc committee, to be chaired by Dr. Goggans, to study the acceptance of EDDA facilities and certificates.
