## **Correspondence from Diana Castro**

## Correspondence from Stephanie Lotti, GDA

The Board considered this correspondence regarding patient generated referrals and whether or not it is permissible for a dentist to extend a token of appreciation to the referring patient and if so, are there restrictions on the value of such a gift or service. Dr. Godfrey responded by stating that this topic has previously been referred to the Rules Committee and made a motion to include this correspondence with the previous correspondences being considered. Dr. Mayfield seconded and the Board voted unanimously in favor of the motion.

## Correspondence from Dr. Randy L. Kluender, The Georgia School of Orthodontics

The Board considered this correspondence requesting guidance on whether an active Georgia dental license is required for participants in the school's non-accredited fellowship program, or if participants can be treated the same as its orthodontic program residents who do not need an active Georgia dental license. Dr. Nalley made a motion to direct staff to respond to Dr. Kluender by stating that because the fellowship program is non-accredited, participants would be required to hold a Georgia dental license. Dr. Holcomb seconded and the Board voted unanimously in favor of the motion.

Dr. Steve Holcomb made a motion and Dr. Logan Nalley seconded and the Board voted to enter into **Executive Session** in accordance with O.C.G.A. §43-1-19(h)(2), §43-11-47(h) and §43-1-2(k) to deliberate and receive information on applications, investigative reports, and the Assistant Attorney General's report.
