Open Session

Dr. Bennett established that a quorum was present and called the meeting to order at 9:10 a.m.

Course Approval Discussion

The Committee discussed the CE provider application submitted for Therapeutic Botulinum Neurotoxins for Dentistry. Dr. Nalley made a motion to table this course submission to allow for adequate time to review. Dr. Gay seconded and the Committee voted unanimously in favor of the motion.

The Medical Board was unaware that the Georgia Board of Dentistry only has one approved injectable pharmacologics course at this time. Dr. Bennett emphasized the importance of gearing courses towards dental practitioners in dental settings. Dr. Nalley made a motion to uphold the denial of the course submission. Dr. Gay seconded and the Committee voted unanimously in favor of the motion.
