- Request from Dr. Debra M. Wilson, DMD to allow dental hygienist to work without direct supervision in Department of Juvenile Justice Facilities.
 - Board response: Notify Dr. Wilson that the request is **denied** as Georgia Law O.C.G.A.§43-11-74(d) does not allow.
- Request from Dr. Gerald Benson re: CE courses prior to licensure consideration
 - Board response: Notify Dr. Benson that a 10 hour hands-on composite course & a 30 hour course in General Dentistry is all that is required; and that the courses do not have to be taken at Medical College of Georgia.
- Request from Rachel Hodge re: licensure consideration for a graduate on a non-accredited hygiene program.
 - Board response: Notify Ms. Hodge that the request is **denied** as Georgia Law O.C.G.A.§43-11-71 does not allow.

- Last month, the board voted to recommend Ms. Edenfield from Armstrong Atlantic University to CRDTS as a Hygiene Examiner. This month the Board reconsidered that vote and voted to notify CRDTS to request that they not use Ms. Edenfield. To assure that there is no perception of favoritism, the Board does not want to use educators from Georgia as examiners.
- Dr. Holcomb has been approached by Representative Greg Goggans to query – Would the board consider having a Manpower Survey conducted at the same time as license renewal? He stated that participation in the survey would have no impact on renewal of a license. The Executive Director expressed some of the administrative issues that would need to be worked out. The Board voted that they are interested in getting more information as to the proposal.

Dr. Holcomb made a motion, Dr. Hadley seconded and the Board voted to enter into **Executive Session** in accordance with O.C.G.A §43-1-19(h)(2) and §43-1-2(k) to deliberate on applications and enforcement matters and to receive information on applications, investigative reports, and the Assistant Attorney General’s report. Voting in favor of the motion were those present who included Drs. Carlon, Carroll, Godfrey, Stacey, and Ms. Richardson. The Board concluded **Executive Session** in order to vote on these matters and continue with the public session.
