**Conscious Sedation/General Anesthesia Committee** – Drs. Clyde Andrews and Barry Stacey

**Rules Committee** – Dr. Clyde Andrews

- Rules committee met prior to the board meeting. Revised rules will be presented on the September board meeting agenda.

**Credentialing Committee** – Dr. Becky Carlon

- Dr. Carlon made a motion that pursuant to O.C.G.A. 43-11-41 and Board rule 150-7-.04, after a period of two (2) years after the issuance of a credentials license, such license shall be revoked unless the license holder has established full-time practice in Georgia.

**Investigative Committee** – Dr. Logan Nalley, Jr.

- Dr. Ty Ivey presented to the board as an individual citizen because he had been asked the status of a complaint filed with the GBOD several months ago by the dentist that had initiated the complaint. Dr. Ivey stated he believes that two elements are necessary for the GBOD to achieve successful complaint resolution for the benefit of the public. Citizens must first raise complaints while secondly; a dentist must risk involvement in the process. Dr. Ivey also commented that many dentists are hesitant to get involved with these procedures because they perceive the GBOD will not follow through with the matter. He asked the GBOD to help resolve these serious matters such as the unlicensed practice of dentistry so that dentists will not become disenchanting with the process."
- Ms. Elaine Richardson, the Board's consumer member voiced her concern regarding felony unlicensed practice and its impact on the citizens of Georgia.

**CRDTS Examination Report** – Dr. Clark Carroll

He is asking for a report to come to the board at the September Board meeting.
