Open Session

Dr. Holcomb established that a quorum was present and called the meeting to order at 10:23 a.m.

Introduction of Visitors

Dr. Holcomb welcomed the visitors.

Appearance

Appearance by Dr. James Talbot: Dr. Talbot thanked the Board for the opportunity to speak to its members. Dr. Talbot explained that he is requesting the Board change his public consent order to a private consent order. He stated that since his consent order is public, it has created a number of issues for him. For example, he stated that it creates issues with credentialing. He stated that there are several insurance companies that will not credential an individual if the status of his/her license is probation. He explained that he would like to relocate to the North Georgia area as there would be a number of available positions for him near his family if his license were not on probation. There being no questions from the Board, Dr. Holcomb advised Dr. Talbot that the Board will take his request into consideration and will notify him in writing of its decision.

Approval of Minutes

Dr. Godfrey requested to discuss the Executive Session minutes in Executive Session. The Board recommended tabling approval of the Public and Executive Session minutes for the May 6, 2016 meeting until later in the day to allow further discussion by the Board.

Licenses to Ratify

Dr. Goggans made a motion to ratify the list of licenses issued. Dr. Godfrey seconded and the Board voted unanimously in favor of the motion.

Petition for Rule Variance – Courtney Talley

Discussion was held by the Board concerning the definition of "Full Time Clinical Practice" in Rule 150-7-.05 Dental Hygiene Provisional Licensure by Credentials. Dr. Holcomb stated there are a significant number of dental hygienists that practice on a part time basis and asked the Board if this is an issue that may need reconsideration. Dr. Nalley made a motion to deny the rule variance petition. Ms. Bynum seconded and the Board voted unanimously in favor of the motion.

In the same motion, the Board voted to refer Rule 150-7-.05 Dental Hygiene Provisional Licensure by Credentials back to the Rules Committee for further consideration regarding the definition of "Full Time Clinical Practice".

Dr. Nalley made a motion to deny the rule variance petitions. Dr. Treadway seconded and the Board voted unanimously in favor of the motion.

EDDA Review Committee – Dr. Greg Goggans

Dr. Goggans reported that he knows those facilities that have submitted information to the Board for review/approval are anxious to hear the Board's response. He stated that he would like to ask the Board for a little more direction concerning the newly created EDDA Review Committee. He stated that the Committee will be meeting in July and asked if it was the Board's will for the Committee to approve individual submissions or should the Committee need to develop certain standards regarding what functions an EDDA needs to do. Dr. Godfrey responded by stating that he would like for the Committee to determine what criteria is commonly used to help establish standard requirements. Dr. Goggans stated that the Committee will meet and report back to the Board with suggestions.

Executive Director's Report – Ms. Tanja Battle

Ms. Battle reported that there is a new vendor for the PDMP program and the Board will need to vote to release information to them. Dr. Godfrey made a motion to release the requested information to the vendor. Dr. Nalley seconded and the Board voted unanimously in favor of the motion.

Ms. Battle reported that the board office received an inquiry from WREB to conduct a 45 minute presentation regarding the examination. Dr. Holcomb added that he met with the President of WREB in Chicago. He stated that the request is relative to ADA and ADEA push for elimination of a patient based examination and to allow more states to accept more boards. He stated that the ADA and ADEA have no authority over a state's testing requirements. Dr. Holcomb requested the Board's authority for him to draft a letter to ADEA and ADA in response to their request. He stated that he will submit the letter in draft form to the Board at its next scheduled meeting for review. Dr. Godfrey made a motion to approve Dr. Holcomb's request. Dr. Nalley seconded and the Board voted unanimously in favor of the motion.

Lastly, Dr. Holcomb stated in reference to WREB, he feels it would be appropriate to respond by stating that the Board appreciates its offer; however, the Board is involved with CRDTS and at this time, CRDTS is meeting the needs of Georgia with its scoring and criteria. At any such time that should change, the Board will contact WREB if interested.

Ms. Battle presented the Board with a Health Fair Dental Screening Request submitted by Suzanne Newkirk. Ms. Battle added that the event will be held on August 5-6 at the Sheraton Atlanta Hotel. Dr. Nalley made a motion to approve the request. Dr. Goggans seconded and the Board voted unanimously in favor of the motion.
