- Pending adoption of rules concerning sedation permits, the Board voted to consider applicants for sedation permits upon submission of an application and a rule waiver. The DOCS program is given blanket approval; all other programs will be considered by the Board on an individual basis. The rule waiver must be posted for 30 days before being considered for issuance.
- Dr. Trager provided a report from the SRTA Board of Directors meeting.
 - Dr. Trager abstained from voting at the SRTA Board of Director meeting regarding the Virginia RFP/contract.
