- Ms. Bush reported on the deficient dental hygienist from the CE audit recently conducted. Dr. Nalley made a motion to mimic the referrals to the Attorney General's office and Legal Department for Consent Orders. Ms. Richardson seconded the motion and it carried unanimously.

**Conscious Sedation/General Anesthesia Committee** – Drs. Clyde Andrews & Barry Stacey

- Dr. Stacey reported the incorrect verbiage of the sedation rules was posted in the rules on the web site. However, when it was brought to the staff's attention the matter was resolved.
- Dr. Stacey asked about the DOCS program Pediatric Training. The Board states that from the information it has at this point, it does not qualify. Dr. Stacey will talk with John Bitting from DOCS and report back to the Board.

**Dental Hygiene Committee** - Ms. Pamela Bush, RDH

- Ms. Bush reported that on May 28, 2010 there was an open forum held at the Professional Licensing Boards office. This open, public forum was to discuss the implementation of a pilot program to be included in the didactic and clinical training of Registered Dental Hygienists in the Masters Program at the Medical College of Georgia which would teach the administration of local anesthesia and nitrous oxide to clinical competency for pain management. In preparation for the forum, email invitations were sent to all dentists and dental hygienists who had enclosed email addresses at license renewal in December 2009. Prior to the forum, 158 responses to invitations were received by the Executive Director. Of these responses, 81 stated they would attend, 66 stated support of the pilot program, 11 did not support the pilot program.

77 people attended the program as well as Drs. Carlon, Carroll, and Holcomb as well as Mr. Dean, Drs. Caughman, Collins and Ferguson and Ms. Martin. As the chair of the hygiene committee chair, Ms. Bush gave opening remarks. The GDA and GDHA as well as others in attendance were allowed to provide their specific remarks, positions and opinions. The forum was closed by Dr. Holcomb and the assembly adjourned.

- Ms. Bush made a motion that it is the recommendation of the Dental Hygiene Committee of the Georgia Board of Dentistry that the Board support the implementation of a pilot program to be included in the didactic and clinical training of Registered Dental Hygienists in the Masters Program at the Medical College of Georgia which would teach the administration of local anesthesia and nitrous oxide to clinical competency for pain management. Dr. Carlon seconded the motion. The Board members voting in favor of the motion were Dr. Carlon and Ms. Bush. The Board members voting to oppose the motion were, Drs. Andrews, Nalley, Stacey, Cook and Ms. Richardson.
- Dr. Holcomb will draft a letter to MCG that the Board voted in opposition to the pilot program. He will also reiterate his thanks to MCG for their work on this program. Lastly, he requests that this information be archived with the Board in case issue comes up in the future.
