Dr. Holcomb requested that, on behalf of the Investigative Committee, the following statement be put into policy for when the Committee is considering older cases:

“For cases that have gone beyond the reasonable time period of closure or sanction negotiations, the Board will issue notification to the licensee and/or legal counsel that the next level of disciplinary action will be started within 45 days unless agreements have been finalized prior to that date.”

Dr. Holcomb made a motion to accept the above mentioned statement as policy. Dr. Nalley seconded and the Board voted unanimously in favor of the motion.
