Executive Director's Open Session Report: Anita O. Martin

- Request from the Georgia Dental Association to have Dr. Andrews attend the Annual liaison meeting of the GDA Specialties Organizations and Professional Societies on Friday, April 11, 2008 at 12:30 p.m. at the GDA offices. Dr. Godfrey will attend in Dr. Andrews' stead and Dr. Stacey will be available as a back-up.
- Presented a variance request from potential credentials applicant Dr. Nga Nguyen. His practice has been in Canada and he is requesting that it be accepted for his five (5) years of full-time active clinical practice.
 - *Board response:* The board deems it appropriate that the applicant have full-time clinical practice in a reciprocal state. After discussion, Dr. Hadley moved to **deny** the request. Ms. Richardson seconded and the motion was carried unanimously.
- Discussed an email received regarding a dentist being arrested for trafficking cocaine.
 - *Board response:* The Executive Director and the Board Attorney will gather information on this issue and bring before the board for consideration at the March 28, 2008 meeting.
