**Dr. Carroll established** that a quorum was present and the board meeting that was scheduled to begin at 9:00 a.m., was called to order at 9:07 a.m. Dr. Carroll declared a recess to the board meeting and the Agency Review Hearing was called to order.

**AGENCY REVIEW HEARING**

An Agency Review Hearing was held on Dr. Edward Trimmier. The Board voted to revoke the license of Dr. Trimmier.

At the conclusion of the Agency Review Hearing, the Board reconvened at 12:25 p.m.

**Executive Session -**

Dr. Carlon made a motion, Dr. Cook seconded and the Board voted to enter into **Executive Session** in accordance with O.C.G.A §43-1-19(h)(2) to deliberate on enforcement matters and to receive information on investigative reports, and the Assistant Attorney General’s report. Voting in favor of the motion were those present who included Drs. Godfrey, Hadley, Nalley and Stacey. The Board concluded **Executive Session** in order to vote on these matters and continue with the public session.

**Discussion Cases -**

- DENT06-0313 –
  - **recommendation:** The board attorney will consult with the local District Attorney’s office and advise of the board’s decision in this matter.
- DENT08-0253 –
  - **recommendation:** The staff will draft a letter to Smyrna Police Department requesting that they notify the board immediately upon the release of licensee. The board recommended that an OMPE will be required at that time.

- DENT08-0073 –
  - **recommendation:** Licensee has not responded to any of the board's requests. The board recommended to refer this case back to Drugs & Narcotics for an updated report by April 18, 2008. Also schedule for him to meet with the Investigative Committee on April 18, 2008.

  - **recommendation:** Schedule for Investigative Interview.

- DENT08-0041
  - **response:** Records were received today; case pending cognizant review of records.
- DENT08-0069
  - **recommendation:** Close due to no evidence to support claim of practicing dentistry without a license.
- DENT08-0156
  - **recommendation:** Close with a signed ceased and desist order accepted.

Dr. Carlon moved to approve the recommendations made in the Executive Session. Dr. Godfrey seconded and the motion carried unanimously.

The next meeting is scheduled for April 18, 2008 at **12:00 p.m.** There being no further business to come before the Board, the meeting was adjourned at 1:48 p.m.
