According to the Department of Law, State of Georgia, the Georgia State Board of Dentistry has the authority to adopt the proposed rule amendments pursuant to authority contained in O.C.G.A §§ 43-1-7, 43-1-21, 43-11-7, 43-11-43.

At its meeting on June 13, 2014, the Board voted that the formulation and adoption of these amendments do not impose excessive regulatory cost on any licensee and any cost to comply with the proposed amendments cannot be reduced by a less expensive alternative that fully accomplishes the objectives of O.C.G.A §§ 43-11-7, 43-11-9. The formulation and adoption of these amendments will impact every licensee in the same manner, and each licensee is independently licensed, owned and operated and dominant in the field of dentistry.

SYNOPSIS OF PROPOSED AMENDMENTS OF THE GEORGIA STATE BOARD OF DENTISTRY RULE 150-3-.06 DUPLICATE LICENSES. AMENDED.

Purpose of Rule: The purpose of this rule is to permit licensees to order a duplicate copy of their licenses.

Main Features: The main feature of this rule is to no longer require Board members to sign and stamp duplicate licenses.

DIFFERENCES OF THE PROPOSED AMENDMENTS FOR THE GEORGIA STATE BOARD OF DENTISTRY RULE 150-3-.06 DUPLICATE LICENSES. AMENDED.

150-3-.06 Duplicate Licenses. Amended.

(1) Duplicate licenses will be issued in accordance with the fee schedule set forth in Rule 150-12-.01.
(2) Upon receipt of proper proof that the original dental or dental hygiene license was lost or destroyed, the Board will issue a duplicate license, which will be marked as a "replacement" license, showing the date of issuance of the original license. Said replacement license shall be signed by the entire Board on the date that the duplicate is issued.
