- Provided advice on ownership of dental practices. The Board can sanction a dentist who works for a non-licensee. However, nothing in the law prevents a non-licensee from owning a clinic. If complaints are received, they will be investigated to see the Articles of Incorporation and what contractual relationship exists between the clinic owner and the dentist.

**Miscellaneous:**

- Dr. Schultz of the Georgia Society of Oral Surgeons voiced concerns regarding the Provisional License by Credentials. The Board voted to notify DCH that the "Provisional" license is the equivalent of a dental license and has all the same rights and privileges concerning the practice of a Georgia licensed dentist.

Dr. Holcomb made a motion, Dr. Nalley seconded and the Board voted to enter into **Executive Session** in accordance with O.C.G.A §43-1-19(h)(2) and §43-1-2(k) to deliberate on applications and enforcement matters and to receive information on applications, investigative reports, and the Assistant Attorney General's report. Voting in favor of the motion were those present who included Drs. Trager, Andrews, Carlon, Cook, Godfrey, Carroll, Hadley, Ms. Anday and Mr. McDougald. The Board concluded **Executive Session** in order to vote on these matters and to continue with the public session.
