- Mr. Dean discussed the Superior Court review of the Dr. Martin Boeckh's case. Dr. Self has ruled on this case and the case is closed.
- Mr. Dean discussed the correspondence from Frank R. Recker & Associates Co. LPA regarding a judicial ruling advertising decision in Florida. Mr. Dean discussed with the Board challenges to the Florida Board rules requiring a disclaimer and the judge ruled that the Florida Board's rules were unconstitutional. Mr. Dean will develop several possible responses to this matter and will provide them to the Board for its review.
