1. Y. T.S. – Dr. S. and his attorney Melvin Goldstein met with the Board. The Board advised that once it has legal documentation showing his legal name he can be issued a license under his legal name. Applicant needs to be consistent; with dental school transcripts, application, social security card and all documents submitted to the Board for his license, etc. list his legal name.
2. C.L.L. – Dr. C.L. met with the Board and provided additional information concerning his military discharge. The Board recommended upholding its previous denial. The Board would again consider licensure once it is provided with information that the less than honorable discharge issue has been resolved. At that time, Dr. L. will be required to resubmit an application and updated NPDB/HPDB report – the fee will be waived.

Upon receipt of a letter from M.D. stating that applicant is safe to practice with reasonable safety to the public, the Board will issue a Public Consent Order with the following: Standard Impairment with 2 times a month screens, Stay in aftercare program, Consider immediate suspension of license upon any positive screens and require an appointment be requested with the Board one year from the docket date of the order to allow LOC to further evaluate licensee's status.
