- None of the coursework acquired for the consent order can be applied toward the continuing education hour requirement for renewal still needs the forty (40) hours to renew for the 2007 renewal period.

2. DENT06-0195 - Board response:

- Refer to Cobb County District Attorney for prosecution for unlicensed practice on May 4, 2005, May 7, 2005 and May 9, 2005.
- Request that DEA suspend his DEA privileges.
- Refer to enforcement as a high priority case to subpoena patient records and match with prescription records.
- If prescribing irregularities found, send to Attorney General's office to file a Notice of Hearing for Revocation.
