**Minutes from the February 22, 2011 Board meeting**

- Dr. Hadley made a motion to approve as amended. Dr. Nalley seconded the motion and it carried unanimously.

**Conscious Sedation/General Anesthesia Committee Report – Drs. Andrews and Stacey**

- Dr. Stacey discussed that oral surgeons practicing dentistry under their M.D. licenses need to be contacted and notified that they need a general anesthesia permit for each practice locations where they administer anesthesia. Board staff will research and work with Dr. Stacey on this notification

**Media Policy**

Effective January 7, 2011, the Georgia Board of Dentistry voted that it is not appropriate for any one member or a member of the Board staff to make verbal, written comments or statements to any media outlet or to respond to press/media inquires on behalf of the Board until such time as authorized by the Board. Any verbal, written comments or statements to any media outlet or to response to press/media inquiries are the opinions of that Board or staff member only and should not be attributed to or as representative of the Georgia Board of Dentistry.

- Ms. Martin stated that since the time is short between the April and May Board meetings that the thumb drives will arrive later than 10 days prior to the meeting.
- Ms. Martin stated that the next Dental Board meeting is May 6, 2011 at 10:00 a.m. Ms. Martin asked the board members to let her know in writing in you are unable to attend.
